

It has come to my attention that a former acquaintance and “employer” has made some allegations about me, and I’m here to clear up some things. As I don’t want to indirectly incentivise harassment, we’ll refer to them as simply “Blue” when appropriate.

I was not going to acknowledge this, but since people who I care about are being dragged into this situation, I felt it best to make a statement.
