

So, in the past week a *lot* of stuff has happened in regards to the Saberspark/Ilovekimpossiblealot situation. I wasn't going to say anything ahead of time, but with what has transpired in the previous couple of days (and really, among this whole event), I think that it is important to say some things preemptively. And, a lot of people are curious about a lot of things, so I will answer them to the best of my abilities. There are many things I practically can't reveal, and other things I do not yet have the permission to reveal.

1. Yesterday (as I write this), one of the two users who run the Brony Fandont accounts, Bonk, streamed what appeared to be an attempt on their life. First on twitch, and as the twitch accounts were banned, they tried on twitter. They were found, and according to Sophie who also runs the account, they have been admitted to a hospital. They are currently alive, as far as I'm aware.
2. The impetus of this does seem to be caused by a lot of generalized harassment. And it must be said. It doesn't matter what you think of any of the people involved in all of this, outright harassing people is never called for. Even if you believe the worst of Ilovekimpossiblealot or Brony Fandont or the accuser, or even Saberspark, just flaming them with death threats on twitter is not productive at best and detrimental to anything you're trying to do. Do not fucking harass people. I have my own criticisms of everyone involved, but do not fucking harass them.
3. I have seen Saberspark's response to this whole thing. In my personal opinion, it's not a very good response video. He does address the biggest allegation, but only barely. In my personal opinion, it looked to be the first step in setting up a defamation lawsuit towards Ilovekimpossiblealot and Brony Fandont, more than anything else. I don't know if Saberspark *could* win a lawsuit, but in the United States generally speaking, the phrase is "you could sue anyone for anything." I personally believe he will at least try, but we'll have to wait and see on that front. I have also noticed that Saberspark mentioned BlackGryph0n in the video.
4. The accuser is at the very least, a real person. This not an allegation that KP or Brony Fandont conjured up from thin air. It comes from a human being that is not KP or Brony Fandont. They are a real, existent person and I have spoken with them personally (voice call and all). They do exist. I bring this up because a lot of people seem to believe that they simply don't. I know *exactly* who the accuser is. I will not reveal them to the public without their express consent.
5. Speaking of which, I have seen the google doc. My only comment on this is that (to my knowledge), no one on the investigation team had anything to do with it. I do not believe that KP or anyone assisting her wrote it either.
6. I will have to address the long twitter thread that Brony Fandont released yesterday (due to the circumstances, I'd really rather not, but I don't want misinformation to spread). I tried to contact them on Discord as I noticed it, and Phineas has tried to contact them on Twitter, but at present, neither has gotten back to us, at this point for what should be seen as obvious reasons. The thread is mistaken about many things. For some reason, Bonk believes that Lazy Bedhead is making the video? She's not. I am. And we've made this clear to the accuser repeatedly. It was literally one of the first things that I told to the accuser, and it was said again to the accuser on the night of the 12th, so I'm not aware

how that miscommunication happened. My only theory is that in the KP message, she mentions Lazy and not me ("From my understanding you shared a dropbox file with Lazy and... Lazy")

7. We did do a background check on the accuser when we discovered who they were. There were two talks with the accuser directly; one with Lazy Bedhead alone, and one with myself, Phineas, and Lazy Bedhead on the night of the 12th. Being described as "having the allegations thrown their face" is simply wrong. We talked about them. We got the accuser's side of the story. They were able to provide receipts, and while many of them still do need to be verified, they were at least amicable to discussion. We talked about many things, including Saberspark's response video.
8. Yesterday (at night), the accuser did at least message us when we checked in on them.
9. I have no comment at this time on KP's voice message to the accuser. I will only state that we also received this message from the accuser during our call and I have confirmed the accuser did not want the message released publicly.
10. Yes, I have seen Caycifish's message to Rachael (Ilovekimpossiblealot). I will comment on it in the video.
11. Yes, I have seen the full unedited call between Chris and Ilovekimpossiblealot that sparked this whole entire thing. I will also comment on that in the video.
12. Once again, do not fucking harrass anyone. Brony Fandont and Ilovekimpossiblealot didn't vet a story/accuser. That is no reason to issue them death threats, even if you believe that Saberspark is innocent, especially before the dust has settled. A lot of people harassed the accuser's twitter burner account. This is also a fucked up thing to do, even if you think that they're making it up. Until that dust settles (and even afterwards possibly) there's always a chance that they could be telling the truth. I do not believe harassing Saberspark is the correct course of action either. If you believe the worst of him, the correct course of action is justified criticism and walking away from his content, not death threats, cyberstalking, etc.

This investigation is taking longer than anticipated, for various reasons. I do not want to make *any* mistakes with my final judgement in the final video. Because I need to eat, I will be doing my usual work on the side. I would not expect this investigation video to be the next one that I do at any rate.
