I have personally never been angered so much by the reckless and irresponsible actions of another YouTuber. Ilovekimpossiblealot (KP/Rachel) released a video on the first of this month, complete with a premiere and a watch party. You've probably heard of it by now at the very least. It was billed as a takedown of Saberspark, when he had very little to do with the overall video. Even DA Games, the other YouTube channel in the title was an after thought compared to their mutual employee, Chris Aficionado. The video was unlisted and then privated (has since been reuploaded) within hours of its release after immense backlash. The contents of the video have been well-documented and rightfully torn to shreds by several YouTubers, most pertinently by Cartoonshi. It was meant to be about serious subjects from sexual harrassment all the way to rape allegations. The video in turn had cartoon reaction clips, memes, a terrible flow (half of the time you can't tell what the fuck KP is talking about), and Saberspark is largely an after thought.

I was baffled at first, but as the days went on and I looked more and more into exactly what happened and KP's behavior before the release and since, I have grown from confused to angry to appalled. I'll be upfront with the biggest issue here. DA Games does have legitimate accusations that should be looked into. DA Games and their community has hurt someone I know personally. Saberspark does have legitimate controversies that he needs to address that he has been avoiding for years. This video was so *horrendous* it has simultaneously done damage to both stories and has *hurt* people, far more than Rachel seems to realize.

I don't know much about DA Games personally, so I can't comment on that. But I do feel for the people who were hurt there. And I do hope that someone with more competence can tell the full story. Rachel's video was largely billed as a takedown of Saberspark; she teased it for months, the video's title was set up in the vein of Saberspark's videos. I have never seen someone falter allegations so abominably bad.

I've been doing research on this story - I am planning on making a video addressing this situation after I do the due diligence that Rachel failed to. However, somethings I feel must be addressed immediately, with what Brony Fandont has accused KP of the night before this was written.

I'll start by restating what is already known: there were many people asked to lend their voice, people like Lazy Bedhead and Joon the King. None of them were given the full script or context of what they were talking about. Even worse, the "Sonic pissing on the moon guy" was put in without being asked *at all*.

This video had been in production for over half a year, since September of 2024. The initial plan was that it was about DA Games entirely, with Saberspark having an even more minor role. KP got wind of Saberspark's accusation "late in production." She got wind of this in March. March. More than a full month before the video's release, and sat on it. She would say she had "career-ruining allegations towards Saberspark" but would give no details beyond that prior to the video's release.

To put this in perspective, my second video on StarGiantProductions was 100 hours of work and investigation over the course of two weeks. The Mystic Mongrel video, in which I had to comb through thousands of Discord messages and watch 10 hours of video shit fights took roughly 3 weeks. In the month that KP had this allegations, she didn't even *proofread* the initial twitter statement. The alleged victim later clarified on twitter that the second incident happened in late 2012, not 2013. It took me less than an hour to even verify that Saberspark was at the conventions where these incidents were said to have taken place (he was there, at both of them). KP couldn't have been bothered to do that within her own video. The allegation itself is placed in the video with all of the structural integrity of a rickroll.

She was asked several questions. My biggest one was who saw the video ahead of time. Beyond the uncredited editor, I can't substantiate anyone. KP claimed that besides the editor: one of her mods saw it, a couple of DA Games victims saw it, and Saber's alleged victim saw it. According to KP, Lio Convoy and Courtney Peet were sent the video and neither watched it prior. According to Brony Fandont, if his twitter thread is to be believed, Saberspark's alleged victim never saw the video in its entirety. If Brony Fandont is telling the truth, than KP lied to the face of someone. Someone she asked to be in the video without giving them the full context of. I have my beliefs, but I know for sure that *someone* between these two is lying, and I will get to the truth of the matter.

KP claimed that the video's tone was such a problem because she had never done something like this before. This is a lie. She made a video on Lily Orchard last year. And according to some comments, the tone of that video was meant to be similar to this one until she was begged to stop. Take this with a grain of salt. But as more of KP's former mods and volunteers (she doesn't have workers, she has volunteers) leave in disgust, I'm sure we'll get more stories. And they won't be from anon this time.

Since the video has dropped, KP has been complaining that this has become a ranting about KP and KP's video session instead of actually caring about the victim. Let me tell you the favors that Rachel has done for Saberspark's alleged victim. In the video itself, she shows a clip where Saberspark has threatened her with legal action.

Here's the worst case scenario that Rachel had made a distinct possibility. It's possible for Saberspark to have sexually assaulted this woman on two separate occasions. Rachel, living in pony la la land presented such a poor case she can be sued for defamation over something that *may be true*. And with the cards currently on the table, Saberspark can win that defamation lawsuit, which will prevent the alleged victim from ever getting justice. I'm mad too Rachel, but not because they're making fun of your video, but because they're not realizing how truly toxic it is. *Because of you*. You. You. You. People in general believe that not just Saberspark, but DA Games are innocent of what they may or may not have done. You had six months to make a video, I would've assumed that you would have had one thought since then. I couldn't even follow what you were saying, and I had to follow the broken ramblings of the broken brain of my former editor.

Here's what I know about the specific allegations towards Saberspark. He has publicly defended BlackGryph0n, who met the VA for Sweetie Belle when she was 14 and well into adulthood. When she became an adult, the two married. Saberspark publicly defended him and said things were on the level. Later it was uncovered that BlackGryph0n was publicly flirtatious with a known minor on DeviantArt; that at least two other people are alleging he sent them dick pics when they were minors. Saberspark continually fails to address this situation, and with a platform his size, he has a responsibility to.

Saberspark has been accused of sexual assault twice in 2012 at two separate conventions. I can confirm he was at the events this was said to have happened. I can confirm that there are other people vouching for this woman's story. I can confirm that the person at least exists. I can confirm that this person may have had a reason for staying so quiet for so long. KP's video is not when this person first stepped forward. They first stepped forward when the BlackGryph0n story was gaining more traction, and that should be looked at as to where this story starts, not the monumental catastrophe of someone with poor investigative ethics.

I am currently looking for more information, and will keep my DM's open for the month of May. Do keep in mind that I am working on other projects, but I felt that this is something that is impossible to ignore. KP didn't just make a horrendous video, she made a ticking time bomb. She made allegations, which may be true, look like a joke due to a failure of due diligence and covered it with Seinfeld and Sonic pissing on the moon. Beyond that, she has treated my friends horribly, and I speculate that she lied directly to their faces. Two sides to every story, and KP should be given the chance to prove that BronyFandont was the one lying instead. Once again though, I will get to the truth of the matter.

I believe that Saberspark should be obligated to give his side of the story, publicly. To his audience and address everything. The BlackGryph0n controversy isn't like fumbling criticizing FreedomToons or paying for a DailyWire subscription. This is something that *must* be addressed. He is free to not say anything, but I believe that he owes an explanation to his audience. I believe it's suspicious that when the BlackGryph0n story is gaining mainstream attraction he quietly lets it slide that he's going to be retiring in two years. I believe that time will tell the truth of the matter, one way or the other.

I believe that a re-edit of the video that KP plans on making should be taken as a resignation of her being a content creator. Rachel, literally the only way you can *survive* on this platform is to soul search, profusely apologize, and never tackle serious subject matter in any way ever again. Alternatively, your other choice is to write, record, and edit your videos yourself to an audience of no one for no profit.
